UN Fish Stocks Agreement – Resumed Review

The FSA has recommenced another round of conferences (the first round was held in 2006) earlier this year, with particular attention to illegal, unreported and unregulated (IUU) fishing and maximising State participation in the Agreement. The UN Permanent Forum on Indigenous Issues (UNPFII) met to address the theme "Indigenous peoples: development with culture to address the therne integer load peoples. Development with Culture and identity". It engaged a broad range of participants in discussions of economic and social issues, including the financial crisis, forests, multinational corporations and, most prominently. climate change. The meeting urged support for indigenous peoples' efforts to retain their values, cultures and identities, while engaging in necessary development. Instrument on Mercury
The first session of the Intergovernmental Negotiating Committee to prepare a global legally binding instrument on mercury (INC-1) convened from 7-11 June. With a total of 20 sessions over five days to design and build an instrument on mercury prior to the 27th regular session of the UNEP Governing Council in 2013, there was a delegates' request to the Secretariat for significant intersessional work, including the "elements of a comprehensive and suitable approach" to a legally binding instrument. INC-2 will take place from 24–28 January 2011 in Chiba (Japan). (TRY)

Basel Convention WG Considers Priorities

The Open-ended Working Group has agreed on a 10-year strategic plan for the Convention, which includes greater emphasis on (i) the links between waste management and achievement of the MDGs relating to human health and livelihoods; (ii) stronger controls on the rapidly growing ship dismantling industry; (iii) global recycling guidelines for used computers; and (iv) further support for enforcing the Ban Amendment on the export of hazardous waste from developed countries to developing countries (http://www.basel.int/). Rotterdam Convention Holds Consultation

Delegates from several African nations, as well as non-governmental organisations including farmers' associations, discussed means to strengthen national capacities to identify Severely Hazardous Pesticide Formulations (SHPFs) under Article 6 to the Rotterdam Convention. 41st Ramsar Standing Committee – Hosting **Arrangements and New Initiatives**

On-going discussions relating to its administrative situation - particularly its hosting relationship with IUCN - have begun to receive formal consideration. Examining output of the Convention's Ad Hoc Working Group on Administrative Reform, the Committee favourably considered a proposal to reorganise the Ramsar Secretariat with UNEP, calling on the Working Group to determine more specific modalities for such a transfer, including: consideration of cost differentials. Aquatic Warbler MOU

At a recent meeting, the signatories to the Memorandum of Understanding concerning Conservation Measures for the Aquatic Warbler under the Convention on Migratory Species (CMS) adopted the International Species Action Plan, with the goal of protecting the Aquatic Warbler throughout its range and envisaging concrete actions to be taken by States. Seven European and African States joined the MOU, bringing the total number to 22 (http://www.cms.int/species/aquatic_warbler/aquatic_warbler/meetings.htm). (TRY)



IMO: New Protocol to Convention on Liability for Hazardous and Noxious Substances at Sea Delegates to IMO's HNS Convention adopted the 2010

Protocol to address practical problems thought to be preventing some States from ratifying the Convention. The Protocol establishes a two-tier compensation scheme for damage caused by disposal of hazardous and noxious substances in bulk or in packaged form, amounting to up to US\$375 million. Cross-Regional Meeting on Ozone

European and Central Asian ozone officers met together under the auspices of UNEP and the government of Turkey. The meeting brought together the Regional Ozone Networks focusing on measures for phasing out the use of ozone-depleting substances such as CFCs and HCFCs, through commercial measures relating to new products in refrigeration, air-conditioning and foam production. Caribbean States Discuss Disaster Management

A workshop in Saint Lucia brought together delegates from the Caribbean Community (CARICOM) and other Caribbean States, to discuss proposals for legislation to improve national responsiveness to natural disasters. Aral Sea

In a press encounter upon his return from the Aral Sea, the UN Secretary-General said:

It is clearly one of the worst environmental disasters of the world. I was so shocked. It really left with me a profound impression, one of sadness that such a mighty sea has disappeared. Standing on piers, on what was once piers, I could not see anything - I could see only a cemetery of ships marooned in the sand. It was shocking. I have learnt a great lesson, a very sad lesson and I am sending out this message to the whole world: we must work together - collectively. This is a collective responsibility, a responsibility shared among the communities in the region and shared among the nations of the world.

We should become better stewards in managing the environment. We need to save this planet. We must deliver this Planet Earth to our succeeding generations, so that they can live in a more hospitable, in a more environmentally sustainable way. That is a moral and political imperative of the leaders.

No Consensus on Mediterranean Water Strategy

Representatives of 43 countries at the 4th Euro-Mediterranean Ministerial Conference on Water were unable to agree on the first major strategy of the Union for the Mediterranean (UfM) to establish a political, methodological and financial framework for managing the water resources of the whole basin. Disagreement hinged on how to refer to Palestine, since Israel's representatives were unable to accept the reference to "occupied territories" and proposed the term "territories under occupation", which was not acceptable to the Arab block. EP Reflections on UfM

EU-Morocco Fisheries Agreement

In a previously confidential legal opinion, the European Parliament's Legal Service provided its judgment on the conformity of the 2007 EU-Moroccan Fisheries Agreement with the principles of international law. The Agreement is scheduled to terminate in 2011. It does not refer to Morocco's jurisdictional limits under international rules of self-determination and does not make a distinction between the waters adjacent to Western Sahara and the waters adjacent to the territory of Morocco. Bio-waste

The Commission has released an 11 page communication "on future steps in bio-waste management for the European Union" (http://eur-lex.europa.eu/LexUriServ/LexUriServ.do?uri=COM:20 10:0235:FIN:EN:PDF).

- Halon

The Council has released a draft Commission Regulation seeking to move the Community towards a ban on halon compounds within the next 30 years (http://register.consilium. europa.eu/pdf/en/10/st09/st09075.en10.pdf).

- Illegal Timber Harvesting

After voting last year to ban trade in illegally logged timber, the text is now back at Parliament. Environment Committee MEPs have adopted a draft recommendation for a second reading reinstating most of Parliaments first reading amendments, as they are not satisfied with the fact that EU governments in the Council are shying away from a real ban.

New Earth Observation System

The Global Monitoring for Environment and Security (GMES) satellite system will begin its initial operational phase from 2011–2013. It will allow the EU to systematically monitor and forecast the state of the Earth's subsystems without having to rely on data from American satellites as at present. The major users of the GMES will be policy makers and public authorities who will use the information to prepare better environmental legislation (http:// www.gmes.info/index.php).

The Right to Sanitation

The European Council on Environmental Law (Conseil europeén du droit de l'environnement (CEDE)) has adopted a resolution setting forth a draft European charter on the right to sanitation. Therein, CEDE recommends that European States apply the charter in their policies and legislation, as well as support international recognition of the right to sanitation as a human right. The International Council of Environmental Law (ICEL) will submit the resolution to the UN Human Rights Council.

Environment and the European Court of Human Rights

On World Environment Day, the Council of Europe highlighted the Court's environment-related case-law and its impact on legislative developments in Europe. Examples given included:

- López Ostra v. Spain, 9 December 1994 (health problems in connection with nearby waste plant);
- Guerra and Others v. Italy, 19 February 1998 (dangerous substances released into atmosphere);
- Hatton and Others v. United Kingdom, 8 July 2003 (airport night flight noise);
- Öneryildiy v. Turkey, 30 November 2004 (deaths associated with gas explosion from nearby waste pile); Fadeyeva v. Russia, 9 June 2005 (health problems related
- to nearby steel plant);
- Gómez v. Spain, 16 November 2004 (neighbourhood nightlife noise);
- Tătar v. Romania, 27 January 2009 (health problems associated with nearby gold extraction).

Germany: Renewable Energy Forecast

The German Advisory Council on the Environment has given its opinion that renewable energy could be sufficient to meet Germany's entire energy demand by 2050. Italy: Managers Go To Jail

In a recent court decision in Palermo, three former managers of the Fincantieri shipyard were sentenced to 3-7 years for the negligent homicide of 37 of their workers who died of asbestosis or lung cancer between 1979 and 1997. Additionally, they were ordered to pay damages of over €5 million to the victim's families and the Italian compensation insurance scheme.

UNEP Funding
According to UNEP's 2009 Annual Report, contributions to the Environment Fund grew by over 22 percent between 2006-2007 and 2008-2009, while extra-budgetary contributions increased by over 50 percent in the same period. The top 15 donors pledging to the Environment Fund in 2009 were: Netherlands, UK, Germany, USA, Belgium, France, Finland, Italy, Spain, Denmark, Sweden, Switzerland, Norway, Japan and Canada. REDD+ Partnership

Fifty States have agreed on a framework for the rapid implementation of measures for reducing greenhouse gas emissions from deforestation, particularly tropical rainforests in developing countries. During the Oslo Climate and Forest Conference, partners pledged US\$4 billion for the period 2010–2012 to the global forest partnership. It will be led by two co-chairs and supported with construction to the World Pools and the and supported with secretariat services by the World Bank and the UN. African Economic Outlook 2010
The Organisation for Economic Co-operation and Development, the African Development Bank and the UN Economic Commission for Africa have released a joint publication with the special theme: "Public Resource Mobilisation and Aid". China: Development of Carbon Emissions Trade
A number of unofficial sources, including a report in *Bloomberg Businessweek*, indicate that China is expected to institute an emissions trading scheme by 2014.
