IWC: Atlantic Sanctuary Proposal

At their annual meeting, the Parties to the International Whaling Convention (IWC) have rejected a Latin American proposal to create a "South Atlantic Whale Sanctuary" encompassing nearly all of the Atlantic Ocean south of the Equator and linking the existing Southern Ocean Sanctuary with the Indian Ocean Sanctuary. Late reports from participants indicate that the vote was less rancorous than similar votes in recent years. (TRY)

 Participation at Rio+20
 A small delegation led by the Executive Secretary co-organised a number of events to share experiences and expertise, such as:

- Developing a legally binding agreement similar to the Aarhus Convention in the Latin American Region;
- The expansion of the Water Convention by allowing/ encouraging universal accession by the end of this year; Developing a conceptual framework for measuring sustainable
- development in cooperation with EUROSTAT and ECOSOC amongst others;
- Undertaking in-depth analysis of the outcome of Rio+20 and discussing action with Member States.

- LRTAP

Aarhus Convention Expansion

A recent mission sought to encourage Mongolia to act on its interest in acceding to the Convention, by promoting a better understanding of the benefits and opportunities offered by its framework. Statements by the President and a number of ministers reaffirmed strong support for accession.

Alpine Convention

After years of side-stepping ratification, Italy has implemented eight of the Alpine Convention's nine protocols, excepting the transport protocol owing to allegations that it poses a competitive disadvantage for the trucking industry. Switzerland now remains the only Member State not to have ratified any of the Convention's protocols, espousing the position that Swiss policy is more sustainable than that of any other Alpine State.

A scientific study indicates that GMO plants developed to increase A scientific study indicates that GMO plants developed to increase pest resistance have not met the long-term success that has been, until recently, attributed to them. Central Africa: Tri-National Protected Area

The Republic of Congo (Brazzaville), Cameroon, and the Central African Republic have successfully requested that the United Nations Education, Science, and Cultural Organization (UNESCO) declare a trans-frontier protected area, spanning over 25,000 km² of rainforest, to be a World Heritage Site. Known as the Sangha Tri-National Protected Area, this is the first time any site has been declared spanning three States. The site is one of 26 inscribed this year. Costa Rica/Nicaragua: New Challenges Costa Rica has officially asked Nicaragua for more details about its proposed U\$\$30 billion ECOCANAL project and its potential environmental impacts. The proposal raises a red flag under a previously negotiated treaty, entitled the *Treaty on the Canalization* of San Juan River adopted on 22 June 1940. Costa Rica has requested that Nicaragua supply it with "all documentation related to the possible construction of said canal". (TRY)

- Environmental Law Honour

The American Bar Association will posthumously honour Svitlana Kravchenko with its highest honour in environmental law. The ceremony to convey the ABA Award for Distinguished Achievement in Environmental Law and Policy will take place in Chicago on 5 August.

The head of the Climate Analysis Section at the United States National Centre for Atmospheric Research has reportedly expressed "no doubt" that climate change is "playing a role" in the current spate of wild-fires plaguing many parts of the United States. Cambodia: Irrawaddy Dolphin

The Government of Cambodia announced that it is cooperating with international experts to promote the conservation of the endangered Irrawaddy oceanic dolphin species. The programme involves international scientific experts convened by the Worldwide Fund for Nature (WWF), and purportedly extends to transborder populations of the species, bringing in collaboration with Laos. (TRY)

Australia: Koalas

The Australian Minister of Environment has announced that the Koala is considered a "vulnerable species" under law. The declaration applies only to populations in the provinces of Queensland, New South Wales and the Capital Territory. The government has stated that, in other provinces, populations of the marsupial remain stable (and are in some cases growing). (TRY)
