This call for papers seeks original contributions in all areas relating to current issues in library and information science education with particular emphasis on the ALISE 2000 Conference themes:

- using team-based approaches to build excellence in outreach service
- developing strategies for excellence and innovation in teaching and learning
- meeting the challenges of accountability
- strengthening our field through increased diversity
- meeting the challenges of the changing nature of promotion and tenure
- balancing general and specialized knowledge and practice
- strengthening research support, including integrating user-centered research from related fields, and learning techniques for writing high quality research proposals and increasing support

All submissions will be peer reviewed by an ALISE Jury: Daniel O'Connor (Rutgers), Chair; Nancy Zimmerman (Buffalo); and, Peter Liebscher (Long Island University). Submissions will be judged with the identity of the author(s) removed from the abstracts.

Prospective participants are encouraged to submit abstracts that report on recent research. Contributions to this Call for Papers should not have been published prior to Fall 1999. There are no restrictions on research methodology.

Abstracts should be approximately 1,000 words and include: purpose, method or process, findings, and significance. Decisions for presentation of juried papers at the ALISE Conference will be based on abstracts, and applicants will be notified by October 22, 1999. Those selected for presentation are required to submit a 200 word abstract for printing in the Conference program. A final paper must also be submitted by







December 1, 1999. Diskette and paper copies are required for posting to ALISE's website in advance of the Conference. Papers should be approximately 15 to 20 pages. Authors should be prepared to deliver or summarize the paper in approximately 20 minutes. At the Conference, authors are expected to provide the audience with handouts (approximately 100 copies) summarizing key aspects of the accepted papers.

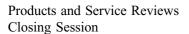
