## 1.4. Restructuring and Adapting LIS Education to European Standards, Thessalonika, 16–19 October 2002

In 1999 Rectors of Universities and Ministers of Education from throughout the European Union made a commitment at a conference in Bologna to restructure courses to a common European pattern of Bachelors and Masters degrees by 2010 in place of the existing, differing national patterns of awards. Implementing these changes, together with the European Credit Transfer scheme and new accreditation and quality assurance systems is affecting the Schools of Librarianship and Information Sciences in a variety of ways. To discuss experiences in adapting to meet European standards and to overcome regional variations in needs and interests, EUCLID: the European Association for Library and Information Education and Research will hold a conference at the Technological Educational Institution of Thessalonika, Greece from 16–19 October 2002.

The themes of the meeting will be restructuring and adapting LIS education to European standards; overcoming regional variations in needs and interests:

- experiences in adapting to the Bologna agreement in defining and structuring Bachelors and Masters degrees
- issues in implementing the European Credit Transfer scheme (e.g. comparability in assessment)
- experiences of accreditation and quality assurance systems
- experiences of collaborative course development

#### 2.1. University of Cape Town, South Africa

Postgraduate Diploma in Library and Information Science (PGDipLIS) This oneyear, full-time, programme focuses on the processes of finding, organising and disseminating information within the context of the 'information society'. It is recognised as a first qualification for anyone wishing to follow a career working with information in organisations or specialising in a professional career in libraries and information services.

Applicants must hold a Bachelors degree in any subject. The programme may also be followed part-time, by arrangement; an evening programme for the PGDipLIS is planned, as an alternative to full or part-time day study. It is expected to start in the latter half of 2002, further details will be available shortly.

Tuition fees for students from the Southern African Development Community (SADC) countries: R11 200 (full time) and R6 000 a year part-time; for students from outside SADC countries: US\$5 200.

Masters Degree in Library and Information Science (MBibl) Two years' duration. The first year (Part 1) is devoted to coursework; for the second year (Part 2), one of three routes to completion may be chosen: (a) dissertation; (b) two additional courses plus a minor dissertation; (c) one additional course, an internship and a minor dissertation. The programme may also be followed part-time, by arrangement. Applicants must hold a Bachelors degree (or a Postgraduate Diploma) in Library and Information Science. Applicants already holding a BBibl (Hons) degree may apply for direct admission to Part 2.

Tuition fees for students from the Southern African Development Community (SADC) countries: Part  $1-R10\,000$  (full time) Part  $2-R8\,300$  a year for coursework plus dissertation options and R6 000 a year for dissertation or dissertation-only option; for students from outside SADC countries: US\$5 200 a year (full-time). Part time fees are charged pro rata.

The Department of Information and Library Studies also offers MPhil and PhD programmes, by research. The study of information use and needs, with a particular focus on information literacy, is the main area of research work of the Department.

#### 2.2. Florida State University, USA

## 2.2.1. FSU Institute receives grant to help develop library plan

The FSU School of Information Studies' Information Use Management and Policy Institute has received a \$40,000 research award from the Division of Library and Information Services to assist in producing a five-year statewide plan for library development in Florida.

The Institute conducts research that focuses on the information user, and the interaction of the user with information products, services, policies, technologies, and organizations.

Charles R. McClure, Francis Eppes Professor and Director of the Information Institute, with John Carlo Bertot, Associate Professor and Associate Director of the Information Institute, will conduct the project. Joe Ryan, Senior Researcher, will also assist in completing the project.

The project will begin in February and will be completed this June. The Information Institute will assist the Division by:

- Holding regional meetings where the broad library community and others can provide input into the development plan. These regional meetings will be held from February—March 2002.
- Conducting a statewide survey assessing key issues and the relative importance of those issues for library development. The survey will be posted on the state library's website during March 2002.
- Providing preliminary findings for public comment at the Florida Library Association annual conference in Daytona Beach, April 10–12.

These efforts will offer the opportunity for all interested in the library development plan to provide input and ideas.

The results from these efforts will be analyzed and reported to the Division to help with library development in Florida over the next five years. The Institute will work closely with staff from the Division to assist them produce the five-year plan.

## 2.2.2. FSU Researchers Produce First-Ever 'GIS' Map of Nation's Libraries

Public libraries are often a focal point of communities. Besides being a source of information, people turn to them in times of crisis. But never before in the history of the United States has there been an accurate map of the actual locations of every public library in the nation – until now.

Florida State University researchers Dean K. Jue and Christine Koontz of the GeoLib Program in the Florida Resources and Environmental Analysis Center (FREAC) have just completed such a map. It is the first map that shows the 16,228 actual locations where someone can go to check out a book. The digital "basemap", a map

to which other layers of data can be coded, uses geographic information system software (GIS) to map the nation's libraries.

GIS combines layers of information about a place to give a better understanding of that place. Combined layers of information might help a business determine the best place to relocate to, or help researchers analyze environmental or sociological problems or trends in a community. When applied to public libraries, librarians might better assess the public they serve.

The researchers found there are 9,039 administrative or "main" libraries that manage an additional 7,189 outlets or "branch" libraries. The total number excludes the nation's 818 book mobiles. More than half of the total number of public libraries are in rural areas.
