#### International librarians' exchange

The Library Association (U.K.) is proposing an international exchange between British librarians and librarians from other countries. The College of Librarianship Wales will be the base for the pilot programme negotiating exchanges between Great Britain and four other countries: Canada, France, Germany and the U.S. The Association has provided the following sample:

#### Information science education for Africa

A joint mission of the UNESCO General Information Programme and the International Development Research Centre toured six African countries in February, to evaluate the demand for a post-graduate programme in information science taught in English. Eight universities in Ethiopia, Ghana, Kenya, Nigeria, Zambia and Zimbabwe were contacted, to sound out their interests. The mission's report is expected to include recommendations for an African programme analogous to the successful Post-Graduate Course in Information Science for Southeast Asia currently offered at the University of the Philippines with support from UNDP, UNESCO, and other sources.

## Training for librarians

Training which is available for librarians in Britain is in great demand overseas. During the last year nearly 300 librarians and information workers came to Britain with British Council help, sixty of them for full-time courses. One of the largest study tours involved a party of thirty Italian provincial librarians whose main interest was the British public library system. A group of Chinese architects and engineers visited Britain to study modern techniques of library design and construction. In particular they were interested in the concrete waffle polypropylene slab construction process used in several modern British libraries and attended a special meeting at the British Library to discuss the plans for the new building under construction on the St Pancras site in London. ## Library training for Pakistan

In common with many other developing countries Pakistan is working hard to improve its university libraries. Other calls on limited funds and a shortage of foreign exchange pose problems. A further problem is the shortage of experienced librarians and a British scheme for training university librarians, worked out between the Pakistan University Grants Commission and the British Council, entered its second phase in March with the visit to Pakistan by John Feather and Inese Smith of Loughborough University. They went to run a three-week course for seventeen librarians and two teachers of library science. They were assisted by one of the seven university librarians who, in April 1982, had taken part in the first phase of the scheme, a three month tailor-made course in library management at Loughborough.

Both phases have been financed by the Overseas Development Administration and it is expected that five or six librarians on the course in Pakistan will be selected for a third phase of further training at Loughborough later this year.

#### New directions project and newsletter

"New Directions in Library and Information Science Education", an 18-month research project funded by the U.S. Department of Education's Office of Libraries and Learning Technologies, has published its first progress report in the form of a Newsletter (March 1983), available free of charge. The project seeks to determine the present and future competencies needed by library and information science professionals and relevant educational requirements.

## Training Seminar on the Universal Availability of Publications (UAP)

One of the recommendations of the International Congress on the Universal Availability of Publications held in Paris in May 1982 was that the UAP programme should be made more widely known such that UAP can be implemented at the regional and national levels. To this end the International Office for UAP of the International Federation of Library Associations and Institutions (IFLA), with UNESCO support, organized a three-day seminar in Boston Spa, U.K. from 21 to 23 February 1983.

# Asian Regional Seminar on Information User Orientation: Needs, Methods and Trends

This regional seminar was organized from 2 to 12 November 1982 by the Institute of Library Science of the University of the Philippines in association with the UNESCO National Commission of the Philippines and UNESCO's General Information Programme,. It was one of a series of regional seminars, workshops and short courses organized on specific topics over the past three years as an integral part of its programmes contributing to the development of effective and efficient information systems and services in the countries of South-East Asia in particular.

The seminar was attended by twenty-seven participants from ten countries of the region, mainly persons working in institutes of higher education and interested in computerized information systems and online searching. Some forty observers, mostly from the postgraduate course at ILS, also took part.

The programme included lectures, demonstrations and practical work on the overall aspects of the basics of user education, work on the use of audio-visual aids in user orientation programmes and on computerized information systems. UN-ESCO's role in assisting in the development of national and international policies and activities was also presented.

The evaluation carried out amongst participants during the final session produced a useful and constructive assessment of the course and showed that it was generally considered to have been productive and successful. Recommendations were addressed to UNESCO, encouraging the Organization to take concrete action to assist the development of courses and seminars on user orientation in library schools of the region, to facilitate the dissemination of PGI documents, to provide equipment and facilities for worldwide information retrieval and to promote the idea of an automated co-operative network for information retrieval at national and possibly regional levels.

# Conferences, seminars

'Education for librarianship at grassroot level' is the theme of a seminar to precede the 50th IFLA conference to be held in Nairobi, Kenya in 1984. The seminar will be held at the Mombasa Beach Bandari College from 12th to 18th August 1984.

#### Permanent courses

European Institute for Information Management

'Information as resource' will be the theme of a new programme. The European Institute for Information Management in Luxembourg is governed by a Board of Trustees representing both business and the public sector in five countries, and is

administered by a select faculty of European information science specialists. Matriculation from a university programme and proficiency in either French or English are requirements. Students may register for individual courses or combinations of courses as well as for the entire programme of 600 hours (cost: 100 000 f-Lux).

# The Hebrew University of Jerusalem

The Hebrew University of Jerusalem offers a Masters degree in Library Science, with or without a specialization in archival studies. Studies leading to a Qualified Librarian's or Qualified Archivist's diploma are also offered. Students entering any of these programmes may choose one of five tracks:

- (1) public and school libraries;
- (2) academic and special libraries and information centres;
- 3) libraries of Jewish studies and research in Judaica;
- (4) information science;
- (5) archive studies.

The 2- or 3-year course of studies allows at most junctures for Judaic options. Students electing archival studies must choose the archival programme at the beginning of their studies; other courses are chosen at the end of the first year. Competence in either French or German – in special cases Arabic, Russian, or Spanish – as a second language is required.

#### Research awards

A teaching package for experimental methods in information retrieval

In order to alert students to the ways in which online bibliographic retrieval systems may develop in the future, and to provide 'hands on' experience of searching using not readily available and advanced methods of information retrieval, F. Wood and P. Willett of Sheffield University propose to develop a teaching package which would enhance courses in mechanical information retrieval. The package will provide a substantial and evaluated database on which searches based on predefined user queries could be carried out and evaluated using recall and precision measures, in addition to the more usual ad hoc queries.

#### Research reports

The Schools Information Retrieval project - SIR

The British Library awarded a series of grants, totalling approximately £50000 over two years, to develop a microcomputer-based information retrieval system for use in secondary schools and to assess its effectiveness. The system demonstrated to schoolchildren the basic principles of information storage and retrieval and has provided a practical system which can be used in the classroom to locate teaching and research materials. This system is known as SIR (Schools Information Retrieval). Six schools participated in the project. The project team supplied each school with a complete package comprising the specially written software, user manuals, and a small demonstration database of about 600 items on current world problems. The team also gave training to staff in the schools involved. The software was written to run initially on a Research Machines 380Z microcomputer, a machine chosen because of its wide use in secondary schools in the United Kingdom, and three of the participating schools were lent a microcomputer by the British Library Research and Development Department for the duration of the project. Since the completion of the project in 1982, the British Library has sought arrangements for the commercial distribution of the SIR software and is hoping shortly to conclude an agreement with Research Machines Ltd for the distribution rights for SIR to run on Research Machines stand-alone disc-based and network machines. In addition, the Department of Industry has funded the conversion of the initial SIR package into a version which will run on the disc-based BBC Microcomputer Model B. Arrangements for the distribution of this version are also currently under negotiation.
