### UN/GA: New President

Ambassador Nassir Abdulaziz Al-Nasser, the Permanent Representative of Qatar to the United Nations has been elected President of the 66<sup>th</sup> session of the General Assembly. Following election, he was presented with the "PGA Handbook: A practical guide to the United Nations General Assembly", which was prepared by the office of outgoing President Joseph Deiss (Switzerland) and the Swiss Mission in New York. ### UNESCO: Preparations for Rio+20

Irina Bokova, speaking before the 186<sup>th</sup> session of the UNESCO's Executive Board, outlined the organisation's preparations for the 2012 Environmental Summit (Rio+20), including the broadened concept of "green societies" and the potential role of the organisation in UNEP's Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES). ### Global Platform for Disaster Risk Reduction (DRR)

The UN DRR Platform held its 3<sup>rd</sup> international meeting, attended by more than 2,600 representatives from over 168 governments, 65 NGOs and 25 intergovernmental organisations. Addressing such issues as reconstruction and recovery, the economics of DRR, and synergies with the international climate

change and development agenda, the session included the first World Reconstruction Conference (WRC), hosted by the World Bank, creating even further opportunities to highlight and address development challenges in responding to disasters triggered by natural hazards. ### CBD/CITES Bushmeat Meeting

A joint meeting of the CBD and CITES Bushmeat working groups has adopted recommendations to the two Conventions' COPs to reverse the growing trend of illegal trade in the meat and other parts of wild mammals, birds and reptiles. ### UNEP: Report on Metal Recycling

The International Resource Panel cites evidence that less than one-third of some 60 metals studied have an end-of-life recycling rate above 50 percent and 34 elements are recycled at a rate of less than 1 percent. ### Forest Europe Ministerial Conference Opens Negotiations

Ministers and high-level forest officials from the 46 States that are signatories of FOREST EUROPE participated in an Oslo Conference, which adopted *inter alia*, the Oslo Ministerial Mandate for Negotiating a Legally Binding Agreement on Forests in Europe,



and the Oslo Ministerial Decision: European Forests 2020, which outlines a vision, goals, targets and actions for European forests. The forum also adopted European 2020 Targets for forests. The report and these documents are available online at <http://www.forest-europe.org/>.

### Initiative to Prepare National Laws on REDD+

Senior legislators from Brazil, Democratic Republic of Congo, Indonesia and Mexico met to launch the GLOBE Legislator Forest Initiative to develop complementary legislation to prepare the way for efforts to reduce emissions from deforestation and forest degradation (REDD). The legislators involved in this new initiative will report back on their progress at the World Summit of Legislators prior to UNCSD (Rio+20). (ATL)

### IUCN:

#### – Mediterranean Red List

IUCN's Red List of Threatened Species now includes an *Overview of the conservation status of the marine fishes of the Mediterranean Sea*. In this document, IUCN warns that more than 40 species of marine fish currently found in the Mediterranean could disappear in the next few years, recommending more intensive implementation of [European] Council Regulation (EC) N° 1967/2006, on sustainable fisheries in the Mediterranean Sea. #### – Revised Focus in Caucasus

IUCN's office in the Caucasus has recently changed its role. It now focuses on strengthening nature conservation through the Caucasus Cooperation Centre through biodiversity conservation and natural resources management. Citing Norway's good record of environmental protection and sustainable development, the OECD's review of Norway's environmental performance notes the country's invigorated

environmental policy, improved air and water quality and fall in the number of threatened species, as well as its active role in spearheading international initiatives on climate change. #### – Revised Directive Regarding Electrical/Electronic Equipment

The European Council has revised its 2003 directive on hazardous substances in electrical and electronic equipment expanding its coverage to include additional product categories, such as mobile phones, refrigerators, electronic toys, cables and spare parts, while retaining temporary exemptions for key energy-saving products relevant to attainment of EU renewable energy and efficiency targets. ### Brazil: New Study Charts Deforestation Increases

A new study by Imazon has documented continuing increases in the rate of deforestation in the Brazilian Amazon region. ### Canada: New Protected Area on Indigenous Lands

The government of the province of Manitoba has declared more than 8,000 km<sup>2</sup> of boreal forest and wetlands on First Nations land on the east side of Lake Winnipeg as protected territory. ### Croatia: New Protected Area Faces Challenges

Members of the NGO community have filed appeals of the Croatian Water Management Board's series of navigation and flood protection projects affecting the Hungarian and Serbian border area which is within the recently declared Mura-Drava-Danube Biosphere Reserve. The European Commission and the EU-Foreign Ministers are requested to take these actions into consideration in July when they consider Croatia's accession to the European Union. ### Madagascar: Major Programme for Species Protection

The government of Madagascar reports receiving a World Bank loan of \$52 million to help protect rare biodiversity that has come under increasing threat during a protracted political crisis. This is the Bank's first loan to the country since suspending its Madagascar programme following Andry Rajoelina's military-backed coup in 2009. The decision to commit these funds does not signify re-engagement with the country, however, as the money will be channelled through independent organisations rather than directly through the government.
