Semi-structured interview and focus group question guides

Participant Interview One: Start of trial

1. Can you confirm that you have read the information sheet and that you are aware that we are interested in exploring your motivation, challenges and experiences whilst being a participant in the Simvastatin trial?

2. How you are experiencing living with Parkinson's currently? (Prompt questions: physical, emotional, degree of limitation)

3. How does this impact upon you and how does this make you feel?

4. Would you tell me the reasons why you decided to be involved in this trial?

5. Do you understand what is involved in the trial?

6. Can you tell me about your experience of being involved in the trial? (prompt questions: challenges, what went well)

7. Have you any ideas and suggestions that you could make to assist others to participate in a similar trial?

Participant Interview Two: End of Trial

1. How would you describe your experience of being a participant in the PD STAT Trial?

4. Would you describe how your Parkinson's disease is affecting you now and if you have noticed any changes since being involved in the trial.

Mid-point Participant Focus Group

Explain the purpose of the focus group

- 3. You explained your motivation for joining the PD trial, has this changed in any way?
- 4. What are the challenges that you have faced in continuing to participate in the trial?
- 5. Can you explain how you manage to take the trial medication?

6. Would you mind sharing how living with PD is affecting your life now? Is this the same, better or worse than when you began the trial?

7. How would you describe your exercise regime? Is this better, different or worse than before you developed PD?

8. Would you recommend to other people to participate in PD research?

9. Have you any ideas as to how we could improve the PD trial?

Interview with Ineligible trial participants

1. Can you confirm that you have read the information sheet and that you are aware that we are interested in exploring your motivation for participating in the Simvastatin trail?

2. How are you experiencing living with Parkinson's currently? (Prompt questions: physical, emotional, degree of limitation)

Research Staff Telephone Interview
